TERMS OF SERVICE

A) TRAVEL FEE: THE ARTIST REQUIRES A MINIMUM OF 3 MAKEUP SERVICES TO BE COMPLETED WHEN TRAVELING. THE ARTIST WILL PROVIDE 3 OR MORE MAKEUP SERVICES WITHIN ONE HOUR (DRIVING DISTANCE) FROM FLORIDA, NY. IF THE CLIENT

REQUIRES FURTHER TRAVEL OR NEEDS SERVICES FOR LESS THAN 3 PEOPLE, AN ADDITIONAL \$50 TRAVEL FEE WILL BE REQUIRED.

B) RESERVING YOUR DATE: A 50% DEPOSIT WILL BE REQUIRED TO BOOK SERVICES FOR YOUR WEDDING DATE. THIS DEPOSIT WILL BE CREDITED TOWARD YOUR BALANCE OF THE WEDDING DAY TOTAL AND IS REQUIRED TO HOLD YOUR DATE. THE REMAINING BALANCE MUST BE PAID ON THE WEDDING DAY, PRIOR TO SERVICES BEING PERFORMED.

C) ASSISTANT FEE: FOR BRIDAL PARTIES WITH A SMALL WINDOW OF TIME TO GET READY, THE ARTIST MAY NOT BE ABLE TO COMPLETE THE TOTAL NUMBER OF SERVICES WITHIN THAT WINDOW. BE ADVISED EACH SERVICE TAKES ABOUT 45 MINUTES. IN THIS CIRCUMSTANCE TO ENSURE EVERYONE IS READY ON TIME, AN ASSISTANT MAY BE NECESSARY. ASSISTANT FEE IS \$75 AND WILL BE ADDED TO THE WEDDING DAY PRICE TOTAL.

D) CANCELLATIONS: IN THE EVENT THE CLIENT DOES DECIDE TO CANCEL SERVICES, THE CLIENT WILL LOSE THE DEPOSIT MADE TO THE ARTIST. ONLY IF THE CANCELLATION IS MADE WITHIN THE FIRST 14 DAYS AFTER SIGNING AND DATING THIS AGREEMENT SHALL THE CLIENT RECEIVE A 100% REFUND OF THE DEPOSIT.

BY SIGNING THIS AGREEMENT, I, THE CLIENT HAVE READ AND UNDERSTAND ALL THE TERMS AND CONDITIONS OUTLINED ABOVE. I UNDERSTAND THAT I WILL BE FINANCIALLY RESPONSIBLE FOR TOTAL PAYMENTS ON/BEFORE THE WEDDING DAY, AND ALL DEPOSIT(S) MADE ARE NONREFUNDABLE AFTER 14 DAYS FROM SIGNING AND DATING THIS AGREEMENT. I WILL ABIDE BY THIS CONTRACT.
